Dear Ministers,
Dear Ladies and Gentlemen,

I informed you on 15/16 March 2025 about my extensive criminal complaint filed with the Grand Criminal Senate of the Federal Court of Justice under the overall heading **"Elimination of democracy and the rule of law in the Federal Republic of Germany"** ([IG_K-EU_008]). This sent criminal complaint was only the overarching document of publicly available evidence, comprising approximately 1,200 documents, printed out to approximately 15,000 pages. In this letter ([IG_K-JU_701]) sent to the Federal Court of Justice on 01.10.2024, I draw attention, under the chapter "Applications or demands (URGENT)", to the threat against my person posed by the reported criminals and demand the establishment of personal protection by the Federal Police. I wrote this, unaware that the very next day, 02.10.2024, I would be placed in coercive detention for five months (02.10.2024 – 28.02.2025), organized by the criminals, based on forged documents and with the assistance of various other lawbreakers. I have now submitted the crimes committed against me during this period of arrest and coercive detention in a supplement ([IG_K-JU_709]) with three criminal complaints ordered thereunder to the Grand Criminal Senate of the Federal Court of Justice:

- Complaint_1:** [IG_K-JU_708] Criminal complaint for the disregard and undermining of the constitutional body, the Federal Court of Justice, by its President Bettina Limperg
- Complaint_2:** [IG_K-JU_611] Criminal complaint for all offenses committed against me during **coercive detention** respectively during my **arresting and coercive detenting between 02.10.2024, and 28.02.2025**
- [IG_K-JU_631] 20250406_Analysis and evaluation of the "Decision" of the External Criminal Execution Chamber of the Regional Court of Augsburg at the District Court of Landsberg/L" [IG_K-JU_615] of 28.11.2024 by Dr. A. Rüter
- Complaint_3:** [BAU_008] Criminal complaint for criminal offenses in connection with the violation of the Building Code (BauGB) and the Bavarian Building Code (BayBO) by **those which are responsible in the Lower and Upper Building Supervisory Authority.**

The overarching document to the Federal Court of Justice [IG_K-JU_709] contains a brief description of the background to the creation of the three reports. For all three criminal complaints, there are a number of additional evidentiary, accessible documents. Only the [IG_K-JU_631] is mentioned here because it highlights with particular clarity how the judges are now parroting in the most stupid way what the controlling public prosecutors or political officials of the executive branch chew up and dictate to them (who in turn are bound to the instructions of the party ologians in charge).

Unfortunately, I have only managed to translate the overall criminal complaint to the Federal Court of Justice ([IG_K-JU_709]) and the complaint against the President of the Federal Court of Justice Limperg ([IG_K-JU_708]) into English. Perhaps you can already see from these two documents at the Council of Europe, which are comprehensible in English, that it could also be helpful for you to be able to read [IG_K-JU_611] or even [IG_K-JU_631] in English, in order to gain an even deeper understanding of how far the "rule of law" has sunk and how totally degenerated the Federal Republic of Germany's rule of law has become and to what extent all sorts of state organizations have been affected by it, just to simply take someone like me out of circulation for 5 months in so-called "coercive detention" without any legal means.

I would very much appreciate it if the Council of Europe, mindful of its task, would not consider it an absurd idea to relieve me of the burden of translating [IG_K-JU_611] and [IG_K-JU_631]. Then I could better concentrate on describing what can be learned about the state of our so-called German democracy from my coercive detention. **That was a very clearly formulated question, to which I would like an answer.** You can already gather from my thoughts in my letter to the judges of the Grand Criminal Senate of the Federal Court of Justice a certain fundamental conviction about the definitively lost role of the hopelessly charged/burdended public prosecutors in a future criminal law of the Federal Republic of Germany. It will be impossible for the German judiciary to emerge from this serious state crisis independently and without

the support of the Council of Europe in order to achieve a future “federal German legal system” based on the principles of the rule of law.

Dear Members of the European Parliament,
Dear Ladies and Gentlemen,

as Members of Parliament legitimised by the citizens of European states in democratic elections, I ask you to consider how it is possible that the Council of Europe, although it has been urging its “largest” Member State (the Federal Republic of Germany) for decades to finally put an end to this political justice system and to put an end to the political dependence of its prosecutors “acting as prosecution” in its criminal proceedings. And I ask you to consider how it can be that the Council of Europe is nevertheless calmly watching as the parties oligarchs in this Member State, with the support of their “combat troops” of public prosecutors and courts, are busy establishing the next German dictatorship. How can it be that it is even a realistic possibility that the political persecution of a person who discloses this could have even originated in the Registry of the European Court of Human Rights in Strasbourg (Emails “very important” sent between March 15 and March 24, 2025, with the subject “Elimination of Democracy and the Rule of Law in the Federal Republic of Germany”; [\[IG_K-EU_008\]](#) with attachments) ?

Where will such a Europe lead? Is it already the case that the Germans, with their economic strength and a whole bunch of other conceited grandeur, are driving the other European countries into the next dark ages, or do **you** seriously believe that the abolition of the rule of law and democracy can be limited to one member state?
